COMMENTS OF THE NATIONAL ASSOCIATION OF BROADCASTERS AND THE ASSOCIATION FOR MAXIMUM SERVICE TELEVISION, INC.

The National Association of Broadcasters ("NAB")¹ and the Association for Maximum Service Television, Inc. ("MSTV")² hereby submit these comments in response to the Commission's *Notice of Proposed Rulemaking* in the above-captioned proceeding.³ Broadcasters recognize that it is our nation's best interest to have a comprehensive plan to answer viewer questions that arise at the time of the digital television ("DTV") transition, one that includes contingencies for persons that may not have taken the necessary steps to be prepared by February 17, 2009. Thus, NAB, MSTV and their members have been strong supporters of the Short-term Analog Flash

and Emergency Readiness Act.⁴ We also commend the Commission for its tireless efforts to promote a smooth transition. As discussed in detail below, implementation of the voluntary "Analog Nightlight" program is an important consumer education resource. As such, we make recommendations to (1) expand stations' eligibility beyond current Appendix A to ensure the maximum number of Americans can receive the "Analog Nightlight" program with minimum disruption to DTV reception, and to (2) streamline the application process to ensure maximum broadcaster participation in the voluntary program.

I. Broadcasters' Call Centers and the "Analog Nightlight" Program.

As NAB announced on December 15 (see attached press release), using the Wilmington, North Carolina early analog shut-off and other "soft shut-off tests" conducted around the country as benchmarks, broadcasters project approximately two million calls from viewers over five days after February 17 – roughly half of which would occur in the first day, February 18. Answering those calls will require a coordinated effort by broadcasters, the Commission and other stakeholders, including multichannel video programming distributors ("MVPDs").

To that end, NAB committed to producing and distributing a five to eight minute video in both English and Spanish that is accessible to persons with disabilities and that aims to answer the most salient questions viewers had in Wilmington and other analog shut-off test markets – what happened, how to hook up a converter box, how to scan and rescan for channels on a DTV set or converter box, how to properly select and

position an antenna and a checklist of what to do. We have already scripted the video with production to commence in early January.

We know from Wilmington, and from analog shut-off tests across the country, that the majority of viewers who call hotlines have relatively simple questions. At the end of the video, the program would promote a toll free number for viewers to call, which is the second part of the plan.

NAB is working with a variety of stakeholders to coordinate a national hotline to help handle viewer calls from those awaiting coupons, seeking general information, looking for satellite/cable information and needing help with converter boxes, DTV sets and scanning. We are also closely coordinating with state broadcast associations and local broadcasters. To date, approximately 45 state broadcast associations have set up either live phone banks or automated lines to answer viewer questions. In markets with state association hotlines and call centers, our DTV video could also direct viewers to call those numbers.⁵

NAB's video and the coordinated national hotline will also direct viewers with converter box, DTV set and MVPD-specific questions to manufacturer and cable or satellite hotlines. Approximately seven percent of calls in Wilmington were from cable and satellite subscribers. Another 11 percent claimed their converter boxes did not work. We anticipate that call centers would direct viewers to call a particular cable or satellite company if they identified themselves as a subscriber, or a particular converter

box manufacturer hotline for viewers having converter box issues. At least eight manufacturers currently have phone lines to answer consumer questions.

Television stations across the country are committing to in-station, or market-wide local call centers where possible, to answer questions from viewers when local reception problems are the issue. For spotty or weak signals or other regional issues, our call center would direct viewers to local stations and state association hotlines. To further assist in this effort, NAB will produce a "best practices" checklist for local viewer hotlines. These initiatives are designed to be coordinated with the FCC call center. It is critical that we continue the public/private partnership that has brought us so far in our DTV education effort.

One issue related to the "Analog Nightlight" Program is sponsorship. Although we agree with the Commission that Section 2(a) of the statute limits program material to "only" public safety and DTV transition information, the Commission should not interpret the statute to prohibit stations that may wish to defray the cost of maintaining analog service for an additional 30 days with a "brought to you by" or "sponsored by" or "in partnership with" visual identification *during* the "Analog Nightlight" program. See *Notice* at ¶ 29.

Such voluntary partnerships may include other television stations in the market, MVPD providers, local retailers, local municipalities, or others who could underwrite the estimated \$3,500 to over \$15,000 per station in transmission costs with maintaining analog service. Moreover, in addition to the NAB produced video feed, stations may want to link to or feature videos that demonstrate converter box-specific set ups. See,

e.g., http://www.zenith.com/dtv/setup.html. Although produced by manufacturers, these videos are educational in nature and, as such, should not be prohibited by the Commission. Indeed, the Commission should promote policies that encourage, not preclude or discourage, such marketplace collaboration to ensure each Designated Market Area ("DMA"), where technically feasible, will have an eligible and financially viable operating Nightlight station.

II. Stations Eligible to Provide Analog Nightlight Service.

Turning our attention to the list of eligible broadcast stations, MSTV and NAB believe the Commission should create incentives to encourage stations to participate in the "Analog Nightlight" program. To this end, the Commission has proposed a list of stations that would be eligible to participate by simply notifying the Commission. In other words, stations on the list would not be required make a separate engineering showing. Stations not on the list would be required to file an engineering statement.

At the outset, NAB and MSTV applaud the FCC's concerns about interference to over-the-air digital television service. As we have pointed out in other proceedings, even small amounts of interference can cause a digital picture to freeze and become unwatchable.⁷ This is especially problematic where the interference is permanent, untraceable and cannot be policed. Indeed, we urge the FCC to extend its interference concerns expressed in this proceeding to other contexts as well.

In this proceeding, however, we are in a unique position. It is vitally important that as many stations as possible have the opportunity to participate in the "Analog Nightlight" program. Consumers throughout a television market may need access to the educational and emergency information provided by a Nightlight station. Unfortunately, while the list proposed by the Commission in the *Notice* protects stations from all interference, it may not allow enough stations to participate in the program. For example, the proposed list would allow Nightlight stations in only 136 out of 210 television markets. Moreover, under the proposed list only one station in the New York television market would be eligible to participate.

While the Commission's proposal allows stations not on the list to participate in the program, these stations must file separately and submit additional engineering documentation to demonstrate they will not cause interference. Given the limited time before the transition, many stations may be unable to bear the effort and expense to conduct additional engineering studies simply to participate in the Nightlight program. We believe a better policy would be to allow as many stations as possible to make use of the simple notification procedure provided by the Commission for stations that appear on a pre-approved list.

NAB and MSTV propose the following approach. At the outset, most analog stations now operating on low VHF channels 2-6 should be eligible for Nightlight operations. While these stations make up a majority of analog facilities, there will be relatively few digital stations occupying these channels. Accordingly there will be few chances for either co-channel or adjacent channel interference. We also believe the Commission can create a list of eligible stations based on co-channel and adjacent

channel separations that will allow more stations to participate in the Nightlight program. For example, using a 170 km separation standard for co-channel spacing will allow more stations to participate in the program. We attach a list of eligible stations based on 170 km co-channel spacing. In addition, in those situations where the Commission has granted special temporary authority ("STA") for stations to continue digital operations on their temporary in-core channel after February 18, 2009, and return digital operations to their analog channel after the transition, it could permit those stations to use their analog channels as Nightlight channels during this period.⁸

We recognize that employing this standard may allow more interference to occur than the Commission's current proposal. Nonetheless, the potential for interference at the outer edges of a station's service area must be balanced against the need for DTV and emergency information throughout a station's entire market. In addition, the separations we propose approximate the separations currently used for DTV stations, thereby reducing the potential for significant interference. We also note that the interference that may be caused, if any, is not permanent. At most it would occur for a temporary 30 day period. Moreover, if interference does occur it can be detected easily

and corrected by having the Nightlight stations reduce power. On balance we believe this approach will provide the necessary protection against interference, allow more stations to participate in the Nightlight program and reduce the cumbersome procedures that will discourage stations from participating in the program.

III. Streamlining the Application Process.

To encourage stations to voluntarily participate in the "Analog Nightlight" program, we respectfully request the Commission waive its requirement that stations listed in the *Notice's* Appendix A file an update to their Transition Status Report (FCC Form 387). *Notice* at ¶ 18. Such a requirement is duplicative of the STA applications stations must file in order to remain on air in the "Analog Nightlight" program. In addition, the cost for this filing is substantial and could be a disincentive for voluntary service.

NAB and MSTV applaud the Commission's decision to waive the STA filing fees to "encourage and hasten participation." *Id.* Streamlining the application process to a single filing will accomplish this same result. NAB and MSTV strongly urge the Commission to also adopt this approach for the expanded list of stations identified in Section II, in lieu of the multistep engineering STA notifications, comment filings and Form 387 filings articulated in paragraphs 20-22 of the *Notice*.

IV. Content, Captioning and Emergency Information.

Finally, we agree that the Commission's should refrain from mandating the precise content that stations continuing to broadcast in analog must air, and that examples articulated by the Commission in paragraph 28 of the *Notice* are appropriate

suggestions for Nightlight programming.¹⁰ Broadcasters supported the Act, and, as detailed in these comments, are already committed to airing an informational video that fulfills the terms of the Act and Congress' intent. Stations should have the flexibility to present the information in a way that is most useful and accessible to consumers.

The Commission tentatively concludes that the broadcast of information concerning the DTV transition may be made with either open or closed captioning. *Notice* at ¶ 29. We agree. Such flexibility will allow broadcasters to tailor programming to suit the needs of their DMA, including adding any programming subsequent to the distribution of the NAB-produced video loop. Additionally, the NAB-produced video will be aurally accessible, to ensure that those who are blind or have low vision, receive all pertinent information. We commend our fellow members of the Consumer Advisory Committee who have raised this issue directly with us. As for emergency information, pursuant to Section 79.2(b)(ii) and (iii) of the Commission's existing rules, stations must make emergency information accessible not only to individuals who are deaf and hard of hearing but also to individuals who are blind.

V. Conclusion.

Broadcasters are committed to the successful completion of the DTV transition and look forward to working closely with the Commission in the coming weeks as we

implement the Analog Nightlight service, the national hotline, and educate consumers about the steps they will need to take to upgrade. NAB and MSTV are not alone in this effort. The FCC, the National Telecommunications and Information Administration ("NTIA"), MVPDs, consumer electronic manufacturers and retailers and our DTV coalition partners all play important roles in ensuring a successful transition. For the foregoing reasons, we urge the Commission to implement the recommendations articulated above to refrain from further content requirements, expand the stations eligible to participate in the program and streamline the application process.

NAB Pledges to Establish National Hotline for Digital TV Transition Broadcasters launch additional efforts to assist viewers

WASHINGTON – The National Association of Broadcasters (NAB) today announced that it will create a national hotline to answer calls from consumers about the upcoming transition to digital television (DTV).

The toll-free national hotline will serve as an important resource for viewers seeking general information about the DTV transition or the Commerce Department's TV Converter Box Coupon Program. It will also provide additional resources for pay television service subscribers and consumers with technical questions related to converter boxes and installation.

Based on the results from the September 8 analog shut-off experiment in Wilmington, North Carolina, and the analog shut-off tests already conducted by more than 400 local television stations, NAB anticipates there will be approximately two million calls from viewers during the five days following February 17, roughly half of which would occur on February 18.

And with the recent passage of legislation to voluntarily extend analog broadcasting of DTV-related information for 30 days after February 17 where technically feasible, NAB has proposed broadcasting a brief DTV educational video that can replay on local television station analog broadcasts nationwide throughout the days after the transition. NAB will produce and distribute this program, which will address common questions received from viewers in the Wilmington experiment and other DTV readiness testing.

"Establishing a plan to respond to consumer questions about the DTV transition is another example of the broadcast industry's continuing leadership and unwavering commitment to help Americans prepare for the historic transition to digital television," said NAB President and CEO David K. Rehr. "Utilizing the airwaves, numerous grassroots and marketing initiatives and now a nationwide

hotline, NAB and broadcasters are doing everything possible to ensure a smooth transition for all viewers across the nation."

The NAB hotline will supplement DTV hotlines sponsored by local television stations, state broadcast associations, pay television service providers, the Commerce Department's coupon program and the Federal Communications Commission.

The instructional video that is being developed by NAB will attempt to answer frequently asked viewer questions on such topics as converter box installation, rescanning, antenna positioning and general DTV transition questions, among other issues. At the end, the video will promote the toll-free national hotline number and regional numbers where applicable. NAB outlined these commitments in a letter to President-elect Barack Obama's transition team, which can be viewed at www.dtvanswers.com/presskit.

Multiple efforts to educate consumers are underway across the country as part of NAB's more than \$1 billion DTV campaign to inform and help consumers prepare their homes for the transition. As required by law, all full-power television stations must transition from analog to exclusively digital broadcasting by February 17, 2009. Viewers who rely on antennas to watch free broadcast television must take the necessary steps to upgrade their television sets or risk losing reception after that date.
