A BILL

To establish an additional fund in the Treasury to reimburse costs incurred by terrestrial radio stations as a result of the reorganization of broadcast television spectrum, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Radio Consumer Pro-
- 5 tection Act of 2017".

1 SEC. 2. RADIO CONSUMER PROTECTION FUND.

- 2 (a) Establishment.—There is established in the
- 3 Treasury of the United States a fund to be known as the
- 4 "Radio Consumer Protection Fund".
- 5 (b) AUTHORIZATION OF APPROPRIATIONS.—There
- 6 are authorized to be appropriated to the Radio Consumer
